We encourage you to attend our Sunday services in person. *As of this writing*, masks may again be required, given a recent rise decline in COVID numbers in our area.* You may also attend online. *The UUSA Board of Trustees has voted unanimously to change the COVID-19 Building Use Policy to "mask optional" in most of the sanctuary when the risk level is low. A "mask required" area will be maintained on the balcony, next to the windows. Masks are always welcome. Our new policy depends on weekly tracking of wastewater using BioBot Analytics COVID-19 website. If wastewater tests remain below 1000 copies/mL in Hampshire County, the UUSA will remain in Low or Green risk level and continue as "mask optional." If the risk level increases above that level, we will move to "mask required" or more stringent limits, if necessary. Dedicated Offerings

From September to June, our Society donates each month to a dedicated offering recipient and splits 50/50 every Sunday's offering plate with the recipient organization. We will report in a future newsletter what we raised in November for the Connecticut River Conservancy (CRC), and in December for Etta International, Empowerment through the Arts. In September we raised \$1,000 for UUA Disaster Relief Fund to support the Montpelier VT UU congregation, which suffered a great loss when the Connecticut river flooded its building, and \$1,175 for Maui Strong to support victims of the wildfires which devastated Lahaina in western Maui. Hawaii.

The Dedicated Offerings for the month of January will be for **Reproductive Equity Now**. This organization has been active for 50 years in Massachusetts to create change removing barriers to abortion and other types of reproductive health care. REN is engaged in local organizing and support of agencies such as Tapestry Health and the Abortion Rights Fund of Western Massachusetts. How to Access a UUSA Directory



In **gmail**, hover over the image of the file, and a down arrow appears; click that and it'll be saved to your downloads file.

Co-President's Letter

Beware of Phishing

... Teach a Cybercriminal How to Phish, and You Feed Them for a Lifetime.

Apologies to Maimonides for riffing on his oft-quoted line about teaching self-sufficiency. However, the art of "phishing" has made criminals who lurk on the internet and our inboxes very wealthy.

Phishing is the fraudulent practice of sending emails, texts or other messages purporting to be from a reputable individual or company in order to induce us to reveal personal information, such as passwords, and bank account and credit card numbers. The goal of the cybercriminal is to use the personal information to either hold us hostage for money or get directly into accounts to withdraw money.

Over the Thanksgiving weekend, dozens of us got emails or texts purportedly from Reverend Rachael or me that made similar requests. Fortunately, no one took the bait. We even had someone try to withdraw money from our congregation's bank account with a false check. That too was thwarted.

Phishing threats increased 173% in the third quarter of 2023, according to Vade Secure, a security software vendor. That trend has been consistent for several years.

Why should we at UUSA be concerned? Cybercriminals have been targeting institutions that have lots of personal information yet may not have the best defenses. Vulnerable entities, such as schools, municipalities, and religious institutions, top the list.

Unfortunately, religious institutions have the added burden of being the targets of hate and politically motivated attacks. Though we profess our <u>Second Principle</u> – justice, equity and compassion in human relations – we must protect ourselves from those who do not ascribe to that.

So, how can you keep yourself and the rest of the congregation safe?

- If you get a request from a UUSA leader that looks suspicious, it probably is.
- Look at the email address or phone number to make sure it's legitimate. For example, the emails that professed that they came from me used an address that I don't own. Email addresses can be easy to fake. Don't click on any links or reply to the sender without checking through another channel, e.g., call me to double check the request.
- Report any suspicious emails to Lea and feel free to share your experience on our UUSA Members and Friends Connection email group to help warn others to avoid the scam. If you aren't currently part of this group but would like to be, please contact Gene Herman or Lea to be invited to the group.
- With both texts and emails, if the sender is not legitimate, report them as spam or junk and block the sender of the text.

Several of us at UUSA will be joining the "Digital Security 101 for Congregations" seminar series sponsored by the UUA in January and early February. This will help inform ways that we can make our communications more safe, and formalize those steps in our Safer Congregation Policy.

Be on the look-out for more tips to keep us safe in 2024.
